The Oversight Board to the Successor Agency to the Dissolved Redevelopment Agency of the City of Duarte met in a regular meeting in the Duarte Council Chambers, 1600 Huntington Drive, Duarte, California. Chair Fasana called the meeting to order at 6:04 p.m.

A RESOLUTION OF THE OVERSIGHT BOARD TO THE SUCCESSOR AGENCY TO THE DISSOLVED REDEVELOPMENT AGENCY OF THE CITY OF DUARTE APPROVING A RECOGNIZED OBLIGATION PAYMENT SCHEDULE FOR THE PERIOD JULY 1, 2017, THROUGH JUNE 30, 2018

WHEREAS, as a result of the passage of Assembly Bill 26 from the 2011-12 First Extraordinary Session of the California Legislature ("ABx1 26"), the Redevelopment Agency of the City of Duarte ("RDA") was dissolved on February 1, 2012; and

WHEREAS, pursuant to Assembly Bill 1484 of the 2011-12 Legislative Session ("AB 1484") which amended ABx1 26 (ABx1 26 and AB 1484, collectively, the "Dissolution Act"), the Successor Agency for the former RDA ("Successor Agency") is a separate public agency now charged with winding down the RDA's affairs, including making payments due for enforceable obligations (as defined in the Dissolution Act), and perform obligations required pursuant to enforceable obligations; and

WHEREAS, pursuant to the requirement of the Dissolution Act, the Successor Agency prepared a Obligation Payment Schedule for the period July 1, 2017, through June 30, 2018 ("ROPS 17-18"); and

WHEREAS, the Oversight Board to the Successor Agency has been appointed pursuant to Health and Safety Code Section 34179; and

WHEREAS, the ROPS 17-18 has been presented to the Oversight Board to the Successor Agency for its approval pursuant to the Dissolution Act; and.

NOW, THEREFORE, THE OVERSIGHT BOARD RESOLVES AS FOLLOWS:

- Section 1. That the above recitals are true and correct and incorporated herein and made a part hereof.
- Section 2. The Recognized Obligation Payment Schedule for the period July 1, 2017, through June 30, 2018, attached as Exhibit "A" to this Resolution, is hereby approved.
- Section 3. The Oversight Board authorizes and directs Successor Agency staff to post and submit the Recognized Obligation Payment Schedule as required by the Dissolution Act.
 - <u>Section 4</u>. The Secretary shall certify to the adoption of this resolution.
