**APPROVAL OF MINUTES**

Oloteo motioned to approve the minutes of 06/21/22; Calderon seconded the motion to approve the minutes of 06/21/22, and the minutes were carried unanimously.

**ITEMS OF BUSINESS:**

Public Safety Update presented by Brian Villalobos and Sgt. Stevin Fiedler

Sgt. Stevin Fiedler reported that part one crimes are at 7.27% year to date. The City of Duarte is doing well compared to our surrounding cities. He reported we are seeing an increase in residential burglaries, which includes commercial burglaries as well. He further reported that catalytic converter thefts remain a problem mostly with Toyota. He recommends locking your vehicles and not leave any valuable items in plain sight. He informed Commissioners that additional patrol is still ongoing and special assignment deputies are adjusting their shifts to provide additional nighttime patrol.

Director Villalobos reported that through Measure H the City now has LA-CADA representatives in town every Tuesday focusing on homeless individuals that have been homeless for more than a year. These representatives could take them to get their ID's and get them signed up for programs and hopefully housing. They will also go to court for those homeless individuals with substance abuse problems, talk to the judges and see if they can get placement into their rehabilitation programs.

Mr. Villalobos advised Commissioners that the 210-freeway closure will start again tomorrow at 10:00 pm, which will be a full closure till about 5:00 am between Mt. Olive and Irwindale until next week.

He also provided a 4<sup>th</sup> of July recap since no Commission meeting was held in July. He informed Commissioners that 11 citations were issued on the 4<sup>th</sup> of July. No individuals contested their citations to date.

Lastly, he invited all Commissioners to attend the City Picnic and Car Show on September 24<sup>th</sup> from 11 am to 3 pm.


